May 1 – Last day to add/drop projects without it counting against the club and the individual's honor status. Do not add a livestock unless you have a QA scheduled elsewhere. (This is a Sunday in 2022, plan accordingly.)

May 1 – Most Outstanding Exhibitor Competition Begins - Up-To-Date 2022 Ohio State Achievement Form turned in to the OSU Extension office to declare participation by May 1. Please indicate in a cover letter the specie/s for which you are applying. The completed form and cover letter must be hand delivered or snail mailed. Snail mail must be received by 4 pm this day. No emails or faxes will be accepted. Please plan accordingly.) In 2022, this date falls on a Sunday, please plan accordingly. There are several other steps involved with MOE.
